PRESENTER

oda Kotb is the co-host of the fourth hour of NBC News' *Today* alongside Kathie Lee Gifford. Since joining NBC in 1998, Ms. Kotb has served as a correspondent for *Dateline*, where she has covered a wide variety of domestic, international, and humaninterest stories and features, including Hurricane Katrina, the war in Iraq, the conflict in the West Bank and Gaza, the War on Terror in Afghanistan, and the 2012 Summer Olympics. She also served as host of the weekly syndicated series *Your Total Healtb* from 2004 to 2008.



Hoda Kotb *Co-Ancbor*, Today

A New York Times bestselling author, Hoda Kotb has written three books: *Hoda: How I Survived War Zones, Bad Hair, Cancer and Kathie Lee, Ten Years Later: Six People Who Faced Adversity and Transformed Their Lives,* and *Where We Belong,* which was released in January 2016. Ms. Kotb is a seven-year breast cancer survivor and is involved in several initiatives to raise awareness about the disease.

In 2015, Ms. Kotb was honored with a *Gracie Amard* for Outstanding Host in News/Non-fiction and a *Webby Amard* for her *Truly Brave* music video about pediatric cancer. She received additional *Gracie* awards in 2008 and 2003, the *Alfred I. duPont—Columbia University Amard* in 2008, a Peabody Award in 2006 for her report *The Education of Ms. Groves*, and a 2002 Edward R. Murrow Award. Ms. Kotb was awarded Daytime Emmys in 2010, 2011, and 2012, as part of *Today's* recognition as the best morning news program.

Prior to joining NBC News, Ms. Kotb worked as an anchor and reporter at WWL-TV in New Orleans (1992-1998) and WINK-TV in Fort Myers, Florida (1989-1991).

Ms. Kotb graduated from Virginia Tech University with a Bachelor of Arts in broadcast journalism. She resides in New York City. arc Lasry is the Chairman, Chief Executive Officer and Co-Founder of Avenue Capital Group, a global alternative investment manager focused on distressed and undervalued debt and equity opportunities in the U.S., Europe and Asia. Mr. Lasry, a pioneer in distressed investing, formed Avenue with his sister, Sonia Gardner, in 1995. At present, Avenue Capital is one of the largest distressed debt investors globally, managing assets of approximately \$11.6 billion.

Mr. Lasry is currently a member of the Council on Foreign Relations and serves on the Board of Directors of the 92nd Street Y. Mr. Lasry was a member of the Campaign Committee for UPKNYC, which supported the expansion of universal prekindergarten and afterschool programs for middle-school students. He previously served as a member of the Board of Trustees of The Mount Sinai Medical Center. Mr. Lasry is also a co-owner of the Milwaukee Bucks.

Cathy Lasry is the author of several young adult novels. Previously, Ms. Lasry worked as a book editor. Ms. Lasry sits on the Boards of Trustees of The Roundabout Theater Company and Only Make Believe, which brings interactive theatre programs to children in hospitals and care facilities. She is also on the Advisory Board of New York Road Runners.

Marc and Cathy Lasry are both graduates of Clark University where their support has made possible The Lasry Center for Bioscience, The Cohen-Lasry House (which houses the Strassler Center for Holocaust and Genocide Studies at Clark University), and The Cathy Cohen Lasry Visiting Professorship of Comparative Genocide Studies. Mr. Lasry also received a J.D. from New York Law School.

The Lasrys live in New York and have five adult children, one grandchild, and one on the way.

shamar Gestine is a junior at New Visions Charter High School for Advanced Math and Science III. Yshamar came to NYC from Haiti during 4th grade, unable to identify letters or read words in any language. His mother, Marie Joseph, asked repeatedly for help. Eventually, Yshamar was placed in a special education class, where he made little progress but was promoted each year because he worked hard and behaved well.

For 9th grade, Yshamar landed at New Visions knowing only a handful of letters. Yshamar's special education teacher saw his potential and included him in her remedial reading class three days a week. Using the Wilson Reading System, Yshamar started making progress, but his teachers recognized that he would need a lot more Wilson to make up for lost time and earn a diploma. Unfortunately, rather than providing him with the increased reading remediation he would require to catch up, the DOE directed Yshamar to a less challenging school that was not appropriate for his needs and goals.

Luckily, Yshamar and his mom were referred to AFC, where their lawyer built a strong case that he should remain at his school and receive the additional support his teachers had recommended. As the result of AFC's intervention, Yshamar was allowed to remain at his school, double his Wilson instruction, and receive an iPad to facilitate independent reading and writing. AFC also won Yshamar one-on-one tutoring during the summer.

Yshamar has never given up, and the results of his efforts have been amazing! He has passed three Regents exams and is on his way to a diploma with plans to attend college and become an accountant. AFC is proud to award our 2016 Education Champion Award to Yshamar Gestine.



By Solving Problems for Parents in Need:

Any parent of a New York City public school student knows how difficult it can be to navigate a school system that has 1.1 million children. Our Jill Chaifetz Education Helpline is a crucial resource for New York families having problems with special education, transportation, school suspensions, transfers, and more. Our experienced lawyers and advocates work with parents to get their children the educational support they need in school.


By Sharing Our Unique Expertise in Education Advocacy:

We know that one of the best ways to reach the most isolated students is to collaborate with other organizations that serve them. AFC is currently partnering with twenty organizations funded by the Robin Hood Foundation in areas like child welfare, juvenile justice, and domestic violence. In addition, AFC's highly skilled staff can be found in foster care agencies and community-based organizations across the five boroughs, sharing their expertise in educational advocacy, providing legal representation to families, and helping these partners build their capacity to advocate for the educational needs of the children they serve.



Advocates for Children *at a Glance* *By Understanding and Addressing the Education-Related Challenges Confronting the City's Most Vulnerable Children:*

AFC proudly serves on the frontlines of the fight to champion the education-related rights of children and youth who are most likely to experience failure or discrimination in school because of factors beyond their control.



CHILDREN WITH DISABILITIES AFC's multi-pronged approach is a model for education advocacy throughout the city and state. First, we provide one-on-one legal representation and advocacy to help lowincome families of children with disabilities get the educational services and support they need. Second, we offer free workshops throughout the city to bring training, information, and direct assistance on the education system to parents and the professionals who work with them. Third, we address systemic problems with the education of students with disabilities through our policy work and when necessary, federal litigation.

And finally, we coordinate and lead a collaborative effort called the ARISE Coalition, which brings together more than fifty different organizations and individuals to press for policy change to benefit children with disabilities in the New York City schools.



IMMIGRANT STUDENTS & ENGLISH LANGUAGE LEARNERS AFC's bilingual project staff advocates on behalf of individual parents and their children, trains parents and community-based organizations serving immigrant families on education-related rights, monitors access to interpreters and translated materials in the city's schools, and collaborates with other groups to support communities seeking to improve outcomes for immigrants and English Language Learners.

EARLY CHILDHOOD

AFC's Early Childhood Education Project provides individual case assistance, community education, and policy advocacy to improve access to early childhood education for low-income children, ages 0–5, so that children can enter kindergarten prepared to succeed.

Advocates for Children *at a Glance* CHILDREN IN THE CHILD WELFARE SYSTEM AFC's Project Achieve advocates for the educational needs of children in or at risk of placement in foster care while building capacity in the agencies that serve them. Project staff operates satellite offices in child welfare agencies, providing on-site assistance and training to caseworkers, birth parents, and foster parents so that they can address the



g on-site assistance and training to caseworkers, ents, and foster parents so that they can address the education-related issues affecting their children. Project staff also conducts policy advocacy on the city and state levels to improve educational outcomes for students in foster care.

STUDENTS FACING DISCIPLINARY ISSUES & COURT-INVOLVED YOUTH AFC's School Justice Project (SJP) provides case advocacy and legal representation to address the educational needs of youth facing school suspension or court involvement. Through relationships built with social services agencies, community-based organizations, and community courts, project staff are able to reach the students who often fall through the

cracks. The project also provides trainings and technical assistance to parents, young people, and the professionals who work with them. Finally, project staff advocate for systemic reform with respect to school discipline and school climate, as well as the education of court-involved youth.

STUDENTS IN TEMPORARY HOUSING

AFC operates the New York State Technical and Education Assistance Center for Homeless Students (NYS-TEACHS), which focuses on building the capacity of school districts throughout the state to improve educational opportunities for homeless children and youth.
